

**WARRANT FOR SPECIAL MEETING OF THE  
DRESDEN SCHOOL DISTRICT**

**Hanover, New Hampshire**

**Norwich, Vermont**

The legal voters of the Norwich (Vermont) Town School District and the legal voters of the Hanover (New Hampshire) School District are hereby notified and warned that two phases of a Special School District Meeting will be held as follows:

**DISCUSSION PHASE:** Monday, November 7, 2005, at 7:00 P.M., at Tracy Hall in Norwich, Vermont.

**VOTING PHASE:** Tuesday, November 8, 2005, from 7:00 A.M. to 7:00 P.M. in the Richard Black Community Center in Hanover, New Hampshire (for Hanover voters) and in Tracy Hall in Norwich, Vermont (for Norwich voters).

During the discussion phase, the voters shall have the opportunity to discuss the following Warrant Article.

All voting on the Warrant Article shall be conducted by secret written ballot during the voting phase, as provided in the Dresden School District Procedures for Australian Ballot.

**ARTICLE 1:** Shall the District raise and appropriate the sum of Three Million, Two Hundred Ten Thousand Dollars (\$3,210,000.00) for the construction of athletic fields and accompanying facilities and partially fund this project by the issuance of not more than Two Million Five Hundred Seventy Eight Thousand One Hundred Twenty Dollars (\$2,578,120.00) of bonds or notes in accordance with the provisions of Article VII of the New Hampshire-Vermont Interstate School Compact with the balance to be funded as follows:

1. by the transfer of the remaining balance of the bequest from the Dorothy Merriman Estate, estimated to be Two Hundred Fifty Thousand Dollars (\$250,000.00),
2. by Vermont construction aid, estimated to be Two Hundred Eighty One Thousand, Eight Hundred Eighty Dollars (\$281,880.00),
3. by unrestricted donations to the project, estimated to be One Hundred Thousand Dollars (\$100,000.00)?
